A talk with Jacques Deyirmendjian, who has more than 50 years' experience in gas and energy industries. At Gaz de France, as executive VP (1989), then Deputy CEO (1996) and CEO (2000) of International Affairs and Industrial Partnerships, he was in charge for natural gas / LNG importation and transportation, with a specific focus on security of supply. In 2002 he was appointed Group General Delegate and Chairman & CEO of GDF International.

CEO of Deynergies since July 2005, he has worked as an independent consultant and also as an expert in disputes mainly relating to gas contracts submitted to International Arbitration (ICC and SCC).

Since 2010, he is a board member of Axens, a company in charge of developing IFPEN technology in particular for reducing CO2 emissions.

He was vice-chairman of ICC-France, chairman of French Gas Association (AFG), and of UNECE Gas Center at Geneva.
